Your procedure is going to be carried out under what is called INTRAVENOUS SEDATION. This is performed by an anesthesiologist who will remain with you throughout the procedure. It is important for you to realize that you are NOT GOING TO HAVE A GENERAL ANESTHETIC; that is, you may not be unconscious during the procedure. However, you will feel VERY QUIET, COMFORTABLE AND RELAXED. After the procedure, MOST PATIENTS do not remember what has been going on during this time.

You should arrive ten minutes before your appointment for toilet purposes and to rest. Please remember not to wear any tight sleeves or clothing. Clear fluids are encouraged for up to two hours before your appointment, but no solid food for four hours prior to your appointment please. Failure to comply with this will mean that your IV sedation will not be carried out. It may be convenient to arrive alone, but arrangements should be made for a responsible person to accompany you home, and to remain with you for at least two hours.

Any person accepting an intravenous sedation appointment must specifically agree:

1. Not to drive a vehicle or operate any machinery that day.
2. Not to undertake any responsible business that day.
3. Not to drink any alcohol on the day of your appointment.

A medication fee is made for the anesthetic drugs and equipment that are used. This fee is forfeited if your appointment is cancelled with less than seven days' notice, unless the cancellation is due to personal ill health in which case no charge is made.

IV SEDATION INFORMATION

FEES: Private Billings (non-MSP patients)
\$400.00 per hour \$200.00 per ½ hour

Medication/Equipment/Administrative/Travel Separate Fee Schedule provided.
This is NOT covered by MSP

MSP COVERAGE INFORMATION

- For patients to be covered for their dental work through MSP, please fax letter to MSP (sample provided), explaining the reason for the requested sedation (gag reflex, extreme phobia, medical issues, etc.) This letter is good for one year from the date it is signed.
- Patients 15 yrs and under are covered by MSP without a doctor's signed letter.

Reminder: The drug and equipment fees and the administration fee is not covered by MSP and is the responsibility of the patient.

- Dental implants are not covered by MSP. Private billing rates apply.
- Wisdom teeth removal is not covered by MSP for any patient including patients who are 15 years and under. Private billing rates apply.

Exception to the wisdom teeth removal MSP policy

- When removal is at the same time when a maxillary or mandibular osteotomy is performed
- Mentally challenged patients
- Because of the presence of associated pathology (e.g. a tumour) and then only the wisdom tooth involved with the tumour will be covered
- For patients about to have radiotherapy for cancer of the head and neck

BOOKING INFORMATION

- We do not do sedation on patients 10 years or under.
- We cannot do sedation on women who have recently given birth until at least 12 weeks postpartum.
- **Maximum** booking time per individual patient per day is 4 hours.

- If a patient is having a specific treatment (crown & bridge, etc.) that cannot be completed within the 4 hours and in this case pre-approval is required. Please contact Diane Foorte at MSP, 250-405-3742.
- We require a **minimum** of 3 hours booking time.
- On the day of their sedation, patients who wear body piercings in the tongue, lips, or nose should remove their jewelry
- Patient consent form should be filled out
- **You must have at least 2 E cylinders of oxygen available (preferably 4 if you are booking full days). VitalAire is no longer providing oxygen to dental offices. You may contact Tina Chung at Airgas at 250-383-2442 and she can set you up if you need help with this request.**
